

Mobile Device/Internet Service Stipend Authorization Application Calendar 2023

The use of an employee's personal Mobile Device or Internet Access service for DePaul business purposes is established at the College/Department level by an employee's supervisor or other authorized approving official. Once a business use is established, the College/Department has the option of providing an employee with a monthly stipend for the business use of the employee's personal Mobile Device and/or internet access service.

This application is use by the employee and their supervisor or other authorizing official for purposes of requesting and authorizing a biweekly allowance for university business use of their personal Mobile Device and/or Internet Access service.

Instructions

1. Employee begins the process by entering the following:
 - a. Employee's name
 - b. Employee's Person Number
 - c. Name of the employee's supervisor or other authorizing official, who will be approving the authorization
 - d. Sign the Employee Acknowledgement at the bottom of the form.
 - e. A short justification for the business use of personal cell phone and/or internet access (e.g. "Required to work at home for three days per week")

2. The employee works with their supervision or other authorizing official to determine a reasonable amount of the stipend, for the DePaul business use of the employee's cell phone and/or internet access service, in keeping with the DePaul University Business Use of Personal Cell Phone and/or Internet Access Reimbursement and Submission Guidelines. The amount(s) by either the employee or their supervisor or other authorizing official.

3. Enter the applicable dates during which the stipend will be paid. For example, a stipend intended to be paid over the full calendar year would input January, 2023 to end month: December, 2023

4. The employee's supervisor or other authorizing official signs the form and submits a scanned copy of the form to Payroll Services via payroll_scan@depaul.edu.
